Dear Skaters, Coaches, Parents and Friends:

The Rink at Delanco, Delanco Skating Club and the New Jersey Open committee would like to thank you for participating in this year's event. With your support, the New Jersey Open Invitational at The Rink at Delanco has enabled the New Jersey Open to become one of the longest continuously running state meets in the country.

There will be a \$5.00 Spectator Fee for all spectators, parents and children older than 8 years old.

All skaters will need to sign a waiver. Skaters were supposed to send signed waivers with their applications. Many have not, but most have. Please be warned that skaters will not be able to enter the building without a signed waiver. There are two waivers attached to this final schedule. One is for Adult Skaters and one for guardians to complete for skaters under the age of 18. If you come with your completed waiver, entrance will be fast. Skaters without completed waivers will have to leave the line and complete the waiver before entrance will be granted.

Enclosed is the final schedule for the meet. Please be ready to skate one hour before your scheduled event. Please arrive at least 1½ hours before your scheduled event to allow for possible entrance issues and to allow time to comfortably get ready to skate. Events with the same start time will be warmed up together and judged separately. Please Note: All Bronze Events have been moved from Sunday to Saturday. Primary A Boys and Girls figures and Senior Women Singles have been moved from Saturday to Sunday.

In-region skaters and/or coaches please upload your music into your dropbox. World Skate skaters and/or coaches please upload your content sheets into your music dropbox. If you are out of region, please email your music and content sheets to <a href="MJOpenMusic@gmail.com">MJOpenMusic@gmail.com</a>. Please use .mp3 format and on the file name list the event or events for which the music will be used and the skater's name and club. Please upload or email your music and content sheets no later than May 3, 2025.

Awards will be presented as each event is tabulated.


